

## PARENTAL/GUARDIAN CONSENT FORM

### PL Primary Stars – Sharing/Collecting your child’s information

“We will be provided with personal information about your child by your child’s school, including details of any medical conditions and/or disabilities your child has and their ethnicity.

The information we require / will collate and send share with funders is;
